 - a. *Mayor's Annual Salary Level*

The Salaries and Emoluments Commission recommends no change to the prior methodology of applying annual COLA based upon Anchorage CPI, not to exceed 1.5% annually.

Justification: The Commission appreciates the adoption of its 2014 recommendation and believes that the annual adjustments that began in FY15 to the Mayor's salary for CPI have kept the Mayor's salary from falling further behind other staff salaries. While an increase appears warranted, the current economic climate would not support an increase at this time.

b. *Assembly Monthly Salary Level*

The Salaries & Emoluments Commission recommends no change to the monthly amount of \$900 per Assembly Member and \$1,100 for Presiding Officer.

c. *School Board Monthly Salary Level*

The Salaries and Emoluments Commission restated its 2014 & 2016 recommendation to increase the School Board members' monthly stipend to \$450 and the School Board President's monthly stipend to \$550.

Justification: With the effort and time commitment involved of those serving in this capacity, the Commission believes an adjustment to the monthly rate is appropriate. The public contact and interaction is very high for the School Board. Fuel and other costs associated with attending meetings has increased; it should not cost a member to serve in this capacity.

Currently all school board members earn \$400 per month. The President assumes greater responsibility and authority, and should therefore, be compensated at a higher level than the regular members.

The stipend for the School Board and School Board President has not been adjusted since 1989. CPI adjustments from 1989 to 2018 equaled 76% (based upon CPI for Anchorage Municipality & U.S. Urban). The lack of any stipend adjustment, in conjunction with the decrease in overall purchasing power, as demonstrated by the CPI over the time period since the last adjustment show the justification for an adjustment. Recognizing the current financial pressures facing the School District, the Commission understands that it may be difficult to implement this adjustment now. If not possible, the Commission encourages implementation of this recommendation should the financial picture change.

The Salaries and Emoluments Commission recommends no change to the prior methodology of applying annual COLA based upon Anchorage CPI, not to exceed 1.5% annually.

Justification: The Commission appreciates the adoption of its 2014 recommendation and believes that the annual adjustments that began in FY15 to the Mayor's salary for CPI have kept the Mayor's salary from falling Policy FNSB NO. 01.05 – Attachment 1, Pg. 2 Updated 9/13/17 further behind other staff salaries. While an increase appears warranted, the current economic climate would not support an increase at this time.

b. Assembly Monthly Salary Level

The Salaries & Emoluments Commission recommends no change to the monthly amount of \$900 per Assembly Member and \$1,100 for Presiding Officer.

c. School Board Monthly Salary Level

The Salaries and Emoluments Commission restated its 2014 & 2016 recommendation to increase the School Board members' monthly stipend to \$450 and the School Board President's monthly stipend to \$550.

Justification: With the effort and time commitment involved of those serving in this capacity, the Commission believes an adjustment to the monthly rate is appropriate. The public contact and interaction is very high for the School Board. Fuel and other costs associated with attending meetings has increased; it should not cost a member to serve in this capacity.

Currently all school board members earn \$400 per month. The President assumes greater responsibility and authority, and should therefore, be compensated at a higher level than the regular members.

The stipend for the School Board and School Board President has not been adjusted since 1989. CPI adjustments from 1989 to 2018 equaled 76% (based upon CPI for Anchorage Municipality & U.S. Urban). The lack of any stipend adjustment, in conjunction with the decrease in overall purchasing power, as demonstrated by the CPI over the time period since the last adjustment show the justification for an adjustment. Recognizing the current financial pressures facing the School District, the Commission understands that it may be difficult to implement this adjustment now. If not possible, the Commission encourages implementation of this recommendation should the financial picture change.

Regular board members and alternate members shall be appointed on the basis of their expertise in property appraisals, real estate market, construction, farming, and other fields related to their functions as members of the board of equalization. Regular board members and alternate board members shall serve for three years or until their successors are appointed and qualified. Terms shall be staggered so that approximately one-third of the terms expire each year.

FNSBC 4.28.050 Duties.

The board shall hear appeals brought to it and shall determine equalization thereon. The board may alter an assessment of a property only pursuant to an appeal filed as to the particular property. The board shall not hear appeals that do not relate to assessed valuation unless specifically required to do so by law. The board may adjust an assessment only upon proof by a preponderance of the evidence at the appeal hearing of an unequal, excessive, improper or under valuation.
