## **Submittal Requirements** FNSBC 17.36.020

- Map depicting the location of the road
- Signatures of 75% of property owners adjoining the road to be (re)named
- List favored street name and two alternate names
- Appropriate Fee

## **PROCEDURE FOR PUBLIC ROAD NAMING** FNSBC 17.36

- Within 25 calendar days after submittal of the application, the platting officer shall review the application and supporting materials and do one of the following:
  - If the application is complete, accept the application for review and action by the platting board;
  - If the application is incomplete, return it to the applicant with a written list of deficiencies to be satisfied for acceptance.
- All adjoining property owners will be notified of the request prior to the public hearing.
- Written notification of the Platting Board's decision will be issued to all adjoining property owners.
- The decision may be appealed by submitting written notice of appeal as provided in Chapter 17.68 FNSBC.
- Applicant will be required to provide and install standard street name sign(s) on standard post(s). ***New road name will not become effective until photo verification is submitted to the Community Planning Department that the sign(s) has (have) been installed.***

## **PROCEDURE FOR PRIVATE ROAD NAMING** FNSBC 17.40

- Within 5 working days after the submittal of an application, the platting officer or his designee shall do one of the following:
  - Accept the application for review and action;
  - If the application is incomplete, return it to the applicant with a written list of deficiencies to be satisfied for acceptance.
- After acceptance, the Department will process the application within 30 days.
- Written notification of the Department's decision will be issued to all adjoining property owners.
- Any affected property owner may appeal in writing within two weeks of the decision.
- Applicant will be required to provide and install standard street name sign(s) on standard post(s). ***New road name will not become effective until photo verification is submitted to the Community Planning Department that the sign(s) has (have) been installed.***
